AAHRPP Site Visit: WVU OHRP and affiliated offices are currently undergoing re-accreditation through the Association for the Accreditation of Human Research Protection Programs (AAHRPP). AAHRPP is an independent, non-profit organization that accredits high-quality human research protection programs in order to promote excellent, ethically sound research. To earn accreditation, organizations must provide tangible evidence—through policies, procedures, and practices—of their commitment to scientifically and ethically sound human research and to continuous improvement. As part of the process, WVU will undergo a virtual site visit on February 9-10 to evaluate our human research protections program. AAHRPP has selected individuals to be interviewed and WVU OHRP has finalized the schedule. (Please note: WVU OHRP will have limited availability for routine questions/assistance during the AAHRPP site visit on February 9-10 but will resume regular service Monday, February 13. We appreciate your patience.)

2. Do you need a HIPAA Waiver for your QA/QI Submission? Please note for Quality Improvement, Evidence Based Practice, and Program Evaluation projects conducted by a WVU medicine employee, a HIPAA Waiver is not required. The project is considered to be part of routine job duties (as the project does not meet the definition of research). If you're unsure if you need a HIPAA waiver for your optional WVU+kc NHSR submission, please reference the WVU NHSR Decision Matrix.

Tips and Tricks

- 1. **Ensure study personnel are trained:** To speed submission review and approval, check study personnel training before submitting a protocol by clicking the "Personnel" tab at the top of the WVU+kc submission and looking at "Person Details" for each person. *Bonus*: Attach a training certificate here if the information does not auto-populate.
- 2. **Protocol Prep Checklist:** Use <u>WVU OHRP's Protocol Submission Prep Checklist</u> when creating and submitting a WVU+kc protocol. It is linked under Step 5 on <u>WVU OHRP's Get Started Page</u>.
